Class of 1968 - 55th Reunion Gift Project

Class of 1968 Endowed Scholarship: This endowed fund providing a need-based scholarship was created in our 50th Reunion year. Since funds for our other 50th Reunion gift project – an HSSC Capital Gift that became the 1968 Classroom in ARH – had to be in hand within five years of Reunion, a number of major donors who wanted to support both gifts directed cash to the capital gift and made estate provisions (“planned gifts”) for the scholarship. The scholarship fund awaits more than \$650,000 in estate gifts – which alone would permit a \$26,000 scholarship – but current cash in the fund will only provide a \$4,500 scholarship for this academic year. It would be great to raise the current cash level of our scholarship fund with 55th Reunion giving so we can offer greater assistance while the classmates who made the bequests are still alive!

Note: Additional planned gifts directed to the 1968 Endowed Scholarship are most welcome. Please check with Buddy Boulton (see below) on how to do it.
